Grace, peace, and hope through our Savior, Jesus Christ.

Day by day ... they ate their food <u>with glad and generous hearts</u>, praising God and having the good will of all the people. – Acts 2:46-47 In May, we meet for our 2024 Synod Assembly under the theme "With Glad and Generous Hearts." The phrase describes the early church as they gathered on Pentecost. It is also an appropriate description of the past year of our life and ministry together.

In 2023, our hearts were gladdened by:

- Your congregation, along with the other 136 congregations in our synod, faithfully proclaiming the Gospel of Jesus Christ in Word and Sacrament, nurturing community, and loving neighbors and neighborhoods.
- The privilege of accompanying congregations in 72 Call Processes; presiding at 14 Ordinations and 30 Installations; and walking with 34 people preparing to become pastors or deacons.
- 142 lay leaders and 28 clergy from 31 congregations learning to be church in the 21st century through our Faith Practices and Neighboring Practices intensive learning communities.
- 6,500 people receiving our weekly enews. (Sign up at mpls-synod.org/sign-up to feel more connected.)
- 100s of rostered and lay leaders involved in synod sponsored peer groups, conferences, and retreats.
- 100s of leaders from synod congregations helping pass the state's "100% Clean Energy By 2040" and "Restore The Vote" legislation that advance both climate justice and racial justice.
- 100s of leaders faithfully serving as Deans, on Synod Council, and Candidacy, Audit, Program Committees.
- 15 gifted and devoted synod staff members: 10 funded by Mission Support from you and other congregations, and 5 funded by Lilly Endowment and other external grants.

We praise God for the congregational generosity that makes all this happen. At the same time, we recognize that mission support from congregations has declined 16% over the past 10 years, resulting in a reduction in synod staff hours. Especially as we prepare to elect a new bishop this spring, we invite you to consider strengthening your support for the future of the synod's work.


Conference Assemblies are just around the corner: Saturday, February 10, 9:30 a.m. – Noon. Of particular importance will be conference nominations for bishop as well as for voting members to the ELCA Churchwide Assembly, July 28 - August 2, 2025. We encourage congregations to send the same voting members to both the Conference and Synod Assemblies.

As we look at declining mission support or grieve the closing of a congregation, we can become discouraged. In such moments, I encourage you to listen to a remarkable conversation from our 2023 Synod Assembly. Our keynote speaker, the Rev. Otis Moss III, was asked: "what do you say to those who think the church is dying?" Filled with courage and hope, Moss responded, "the church is not dying, it is being born, refashioned, and remade. The early church was an alternative community. Today we use the metrics of the market to evaluate the church – buildings, budgets, numbers. But, the early church looked at *impact*: were people hearing the good news of Jesus who lived and died for our salvation? Was suffering being relieved? Were people being welcomed and healed?" Rev. Moss reminds us that we are called to be alternative communities. What might it take to measure our churches by *impact*? The work of synod leadership is to support the 137 communities and the thousands of leaders who are making an *impactful* difference in the 21st century: sharing the good news of Jesus, extending radical welcome into beloved community, engaging their neighborhoods in love with justice.

I am filled with both gratitude and sadness as I write this, my final annual report to congregations. I have loved serving as your bishop and am profoundly grateful for this calling. We pray for the year ahead, trusting in the goodness and faithfulness of our God, made known in Jesus Christ.

#### I. Call to Order-Dina Strachota

Congregation President, Dina Strachota, called the meeting to order at 11:53 am.

Dina did ask that Trust Fund Committee Member changes be added to the agenda under New Business.

#### II. Determination of a Quorum

It was determined that we have a quorum present.

#### III. Welcome-Council President

Dina thanked Pastor and the council for all their hard work during the past year. She also thanked all those who helped in getting the building ready for Aldersgate United Methodist Church to begin sharing our building, worship space. AUMC has signed a lease for 2023.

#### IV. Approval of 2021 Annual Meeting Minutes

Members had the opportunity to read the minutes prior to this meeting. Dina, Congregation President, asked for a motion to approve the 2021 minutes as written in the Annual Report.

**Motion:** To approve the 2021 Annual Meeting Minutes as written. **Vote:** M/S/C with no discussion

#### V. Pastor's Report – Pastor Durk Thompson

Pastor thanked Dina and the entire council for all that has been done this past year.

Pleased that AUMC has shared our space for half the year, we look forward to start moving into shared ministries. Pastor Paul will be leaving and a new Pastor will be starting in July.

Pastor briefly remined us of the stories about the lost sheep, the lost coin, and the lost son. The son wanted to return, but was afraid. When he did return, he was welcomed with open arms. This is the same for our congregation-members may have left and some may return. And there will be new members who may join. We will continue to welcome them with open arms and embrace them.

#### VI. Treasurer's Report-2022 Budget Recap-Cindy Guddal

Giving was down \$13,000 counted from envelopes, loose, and PayPal. \$24,000 was taken from the ALC fund. Part of the funds are in a conservative account; and there was also a loss because of the current stock market.

Expenses were in line as planned. We are currently doing ok with cash flow.

There was no further discussion or questions regarding the 2022 Budget Recap.

#### VII. Old Business

#### a, Constitution-second vote for final approval

We voted at the last congregational meeting to approve the changed Constitution. We now have our second approval vote. Some of the wording in this constitution was changed prior to the last vote. One difference is that a quorum needed for a congregational meeting will be 25% of the voting membership rather than a specific number.

Bylaws are an identifiable part of the body of the Constitution rather than being a separate document.

**Motion:** To approve by 2nd vote the Constitution of Spirit Of Christ Community Lutheran Church

#### VIII. New Business

#### a. 2023 Proposed budget-Cindy Guddal

Members had the opportunity to review the proposed budget prior to today's meeting.

We need to note that this will be the first full year with AUMC rent as part of the budget.

There is a reduction in the regular giving catagory because of past history.

We still include the \$24,000 from the ALC fund, \$2,000 per month. We will designate \$4500 to the Synod, and \$4500 to the Social Action Committee.

We will tithe from the money taken from the ALC fund; this will be a de cision of the Council.

Utilities will go up as the building is being used more often.

Maintainence and snow plowing budget will stay the same; this is hard to predict.

Pastor's salary was increased to match the synod guildelines, and a 5% increase give to the Parish Coordinator and the Music Dirctor. We do end with a negative budget of \$4700. **Motion:** To accept the proposed 2023 budget as presented. **Vote:** M/S/C

#### b. Trust Fund New Members - Carolee Cohen

Carolee stated according to the Trust Fund rules, members may have (2) 3 year terms. She thanked Barb Endres Erickson, Matt Klinkhammer and Dave Latvala for their service on the committee.

New members will be Joanne Stone, Jennie Mornes, and Renee Compo. **Motion:** To accept the new members of the Trust Fund Committee. **Vote:** M/S/C

#### IX. Nominations and Elections

## **Mission & Social Action**

In 2023, the Social Action team focused on activities that Spirit of Christ members could participate in to keep a congregation-wide focus on our Social Action mission:

The Mission and Social Action Committee shall oversee this congregation's mission and social outreach activities to engage with others in compassionate, caring and helpful service to those in need, engender awareness of community issues and provide opportunities to partner with others in the community to arrive at solutions that are based on a ministry of Christian love, and contribute to the mission of this congregation.

#### 2023 Summary

A part of the Spirit of Christ 2023 annual budget, you approved **\$4,500** for Social Action activities. Here is a summary of how the Social Action team chose to use your contributions and what this amount bloomed into with your other in-kind donations for the year. You all should be very impressed with these figures!

Cash donations to nine organizations totaling \$3,237!

• STEP

received **\$500** for their fund-raising efforts during Minnesota FoodShare month.

was provided with \$175 in gift cards for school supplies in the summer.

accepted proceeds from the November Bazaar in the amount of **\$1037** and we thank all the members and vendors who brought many creative crafts and goodies that generated these funds.

was given **\$500** in Target gift cards to support their holiday gift drive.

- MoveFWDMN received \$500 to support homeless and at-risk kids and their families with quick-response, barrier-free, no-cost counseling and case management. They serve young people at the older end of the spectrum with a housing program and drop-in for everyone.
- Clare House was sent a donation of \$25.
- **Tapestry** was given **\$500** to support their assistance to immigrants navigating the complicated path to citizenship.

•

In addition, Spirit of Christ members made in kind donations valued at more than **\$32,200** and logged almost **2,700 volunteer hours** to carry out our mission and benefit the following groups:

- SLP Bird Feeder SOC delivered food donations valued at \$1,030 throughout 2023.
- STEP SOC sent backpacks and school supplies along with 394 pounds of food to support the food shelf this year valued at \$2,150. STEP also received donations of bread that 5-10 congregation and community members bagged up every Tuesday. Thanks to the coordination provided by Cheryl and Bret Hanson, over 5,500 pounds of quality bread products valued at approximately \$26,000 retail from Breadsmith could be enjoyed by STEP clients at no cost to STEP. This represents approximately 2,500 hours provided by you, our members, to deliver these baked goods to STEP in 2023. Small groups of people working together can really make an impact!



- Meals on Wheels (Lutheran Social Service) you participated in the November service project making 48 Blizzard Meals valued at \$440 to cover times when meal deliveries are hampered by weather conditions.
- Our Saviours Community Services Volunteers spent 83 hours cooking and serving dinners every other month. We had volunteers ranging from 6 years old to 70+! With fewer groups stepping up to serve meals, your contributions to our Chili Cook-Off last January resulted in a delivery of 13 gallons of chili for the residents to enjoy on nights when there are no



meal providers. Our Saviours also received mittens, gloves, hats made or purchased by members plus hand and foot warmers to keep winter at bay and some shoe storage boxes donated to help them organize supplies. In all, the in-kind donations to Our Saviours totaled **\$1030** in 2023.

- **Camp Noah** For God's Work, Our Hands Sunday, members assembled 50 kids' art supply kits valued at **\$450**.
- Simpson Housing in April, you participated in a baby shower for Simpson Housing and SOC provided three welcome baskets with everything a new baby needs valued at over \$750.

In <u>Isaiah 1:17</u> (The Message) we are asked to: Learn to do good. Work for justice. Help the down-and-out. Stand up for the homeless. Go to bat for the defenseless. Thank you to all who demonstrated a commitment to 'doing good' in 2023 by supporting Social Action activities and sending a message that you are here for our community and especially those who are in need of help with their daily challenges.

As shown in our report, your donations and efforts resulted in donations (that were valued at eight times of the **\$4,500** budgeted amount) of more than **\$35,500** in support of many deserving organizations and people in need. Our budget is like the seeds that were sown that produced so much more with our efforts to support our community and beyond. Thank you all for contributing to the successes of 2023.

Members of the Altar Guild also assist the Worship and Music Committee with decorating the altar and sanctuary for Christmas and Easter.


Members will continue to assist the Worship and Music Team as needed.


#### **Financial Secretary's Report**

This report is focused on the weekly offering which helps pay our general expenses. Ten percent of this giving is used for benevolence above and beyond funds specially designated for missions and other activities.

In 2023, 40 individual members/families regularly gave funds to support our general operations, which is down from 43 last year. This resulted in lower contributions for the second year in a row.





Average weekly giving is around \$38/week, which was the same as last year.
